

## Supplementary Cards Terms and Conditions

- The Basic Cardmember can apply for Supplementary Cards only for family members above 18 years of age.
- The Basic Cardmember is liable for all transactions done on the Supplementary Card. The number of complimentary Supplementary Cards varies with the different American Express Cards, in excess of which the standard Supplementary Card fees<sup>®</sup> will be applicable.
